2 GENERAL INFORMATION

2.1 Eligible Tenderers

2.1.1 This Invitation for tenders is open to all tenderers eligible and described in the tender documents. Successful tenderers shall complete the supply of goods by the intended completion date specified in the tender documents.

2.1.2 Tenderers shall provide the qualification information statement that the tenderer (including all members of a joint venture and subcontractors) is not associated, or have been associated in the past, directly or indirectly, with a firm or any of its affiliates which have been engaged by the Nairobi City County to provide consulting services for the preparation of the design, specifications, and other documents to be used for the procurement of the goods under this Invitation for tenders.

2.1.3 Tenderers shall not be under a declaration for ineligibility for corrupt and fraudulent practices.

2.2 Eligible Goods

2.2.1 All goods to be supplied under the contract shall have their origin in eligible source countries.

2.2.2 For purposes of this clause, “origin” means the place where the goods are mined, grown, or produced. Goods are produced when, through manufacturing, processing, or substantial and major assembly of components, a commercially recognized product results that is substantially different in basic characteristics or in purpose or utility from its components.

2.2.3 The origin of goods is distinct from the nationality of the tenderer.

2.3 Cost of Tendering

2.3.1 The tenderer shall bear all costs associated with the preparation and submission of its tender, and the County Government of Marsabit, will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the tendering process.

2.4 The Tender Document Contents

2.4.1 The tender document comprises the documents listed below and addenda issued in accordance with Clause 2.6 of these Instructions to tenderers

- (i) Invitation for Tenders
- (ii) General Information
- (iii) General Conditions of Contract
- (iv) Special Conditions of Contract
- (v) Technical Specifications
- (vi) Tender Form and Price schedules
- (vii) Tender Security Form
- (viii) Contract Form
- (ix) Performance Security Form
- (x) Manufacturer's Authorization Form

2.4.2 The tenderer is expected to examine all instructions, forms, terms and specifications in the tender documents. Failure to furnish all information required by the tender documents or to submit a tender not substantially responsive to the tender documents in every respect will be at the tenderers risk and may result in the rejection of its tender.

2.4.3 Tenderer's Memorandum

All tenders submitted shall include copies of the following documents: -

- (a) Current Year Single Business Permit by **Marsabit County** or any County of Kenya for the firm tendering
- (b) PIN Certificate of the firm tendering
- (c) Certificate of incorporation for the firm tendering/ Registration Certificate
- (d) VAT certificate of the firm tendering

(e) Proof of having bought tender document (receipt copy).

(f) A valid tax compliance certificate from K.R.A.

2.5 Clarification of Documents

2.5.1 A prospective tenderer requiring any clarification of the tender Document may notify County **Government of Marsabit** in writing at the entity's address indicated in the Invitation of tenders. **County Government of Marsabit** will respond in writing to any request for clarification of the tender documents, which it receives no later than seven (7) days prior to the deadline for the submission of tenders, prescribed in the advert. Written copies of the **County Government of Marsabit** response (including an explanation of the query but without identifying the source of inquiry) will be sent to all prospective tenderers that have received the tender document.

2.6 Amendment of Documents

2.6.1 At any time prior to the deadline for submission of tenders, the **County Government of Marsabit**, for any reason, whether at its own initiative or in response to a clarification requested by a prospective tenderer, may modify the Tender Documents by amendment.

2.6.2 All prospective candidates who have received the tender Documents will be notified of the amendment in writing or by cable, and will be binding on them.

2.6.3 In order to allow prospective Tenderers reasonable time in which to take the amendment into account in preparing their tenders, the **County Government of Marsabit**, at its discretion, may extend the deadline for the submission of Tenders.

2.7 Language of Tender

2.7.1 The Tender prepared by the tenderer, as well as all correspondence and documents relating to the Tender exchanged by the tenderer and the **County Government of Marsabit**, shall be written in English language, provided that any printed literature furnished by the tenderer may be written in another language provided they are accompanied by an accurate English translation of the relevant passages in which case, for purposes of interpretation of the Tender, the English translation shall govern.

2.8 Documents Comprising the Tender

2.8.1 The tender prepared by the tenderer shall comprise the following components: -

- (a) A tender form and a Price Schedule completed in accordance with paragraph 2.9, 2.10 and 2.11 below.
- (b) Documentary evidence established in accordance with paragraph 2.12 that the tenderer is eligible to tender and is qualified to perform the contract if its tender is accepted.
- (c) Documentary evidence established in accordance with paragraph 2.13 that the goods and ancillary services to be supplied by the tenderer conform to the tender documents; and
- (d) Tender security furnished in accordance with paragraph 2.14

2.9 Tender Form

2.9.1 The Tenderer shall complete the Tender Form and the appropriate Price Schedule furnished in the Tender documents, including the goods to be supplied, a brief description of the goods, their country of origin, quantity and prices.

2.10 Tender Prices

2.10.1 The Tenderer shall indicate on the appropriate Price Schedule the unit prices and total tender price of the goods it proposes to supply under the contract.

2.10.2 Prices indicated on the Price Schedule shall be entered separately in the following manner:

- (i) The price of the goods quoted EXW (ex works, ex factory, ex warehouse, ex showroom, or off-the-shelf, as applicable), including all customs duties and sales and other taxes already paid or payable.
- (ii) Charges for inland transportation, insurance, and other local costs incidental to delivery of the goods to their final destination

2.10.3 Prices quoted by the Tenderer shall be fixed during the term of contract and not subject to variation on any account. A tender submitted with an adjustable price quotation will be treated as non-responsive and will be rejected, pursuant to paragraph 2.22.

2.11 Tender Currencies

2.11.1 Prices shall be quoted in the following currencies:

- (a) For goods that the Tenderer will supply from Kenya, the prices shall be quoted in Kenya shillings; and
- (b) For goods that the Tenderer will supply from outside, the prices shall be quoted in US dollars or in another freely convertible currency

2.12 Tenderers Eligibility and Qualifications

2.12.1 The Tenderer shall furnish, as part of its tender, documents establishing the Tenderers eligibility to Tender and its qualifications to perform the contract if its Tender is accepted.

2.12.2 The documentary evidence of the Tenderers eligibility to tender shall establish to the Nairobi City County's satisfaction that the Tenderer, at the time of submission of its tender, is from an eligible source country as defined.

2.12.3 The documentary evidence of the Tenderers qualifications to perform the contract if its Tender is accepted shall establish to the **County Government of Marsabit** satisfaction:

- (a) that, in the case of a Tenderer offering to supply goods under the contract which the Tenderer did not manufacture or otherwise procure, the Tenderer has been duly authorized by the good's Manufacturer or producer to supply the goods;
- (b) that the Tenderer had the financial, technical, and production capability necessary to perform the contract;
- (c) that, in the case of a Tenderer not doing business within Kenya, the Tenderer is or will be (if awarded the contract) represented by an Agent in Kenya equipped, and able to carry out the Tenderer's maintenance, repair, and spare parts stocking obligations in the Conditions of Contract/or Technical Specifications.

2.13 Goods' Eligibility and Conformity to Tender Document

2.13.1 Pursuant paragraph 2 of this section, the Tenderer shall furnish, as part of its tender, documents establishing the eligibility and conformity to the tender documents of all goods, which the Tenderer proposes to supply under the contract.

2.13.2 The documentary evidence of the eligibility of the goods shall consist of a statement in the Price schedule of the country of origin of the goods and services offered which shall be confirmed by a certificate of origin issued at the time of shipment.

2.13.3 The documentary evidence of conformity of the goods to the Tender documents may be in the form of literature, drawings, and data, and shall consist of:

- (a) A detailed description of the essential technical and performance characteristics of the goods
- (b) A list giving full particulars, including available sources and current prices of special tools, etc., necessary for the proper and continuing functioning of the goods for a period of two (2) years, following commencement of the use of the goods by the **County Government of Marsabit**; and
- (c) A clause-by-clause commentary on the **County Government of Marsabit** Technical Specifications demonstrating substantial responsiveness of the goods and services to those specifications, or a statement of deviations and exceptions to the provisions of the Technical Specifications.

2.13.4 For purposes of the commentary to be furnished pursuant to paragraph 2.13.3 (c) above, the Tenderer shall note that standards for workmanship, material, and equipment, as well as references to brand names or catalogue numbers designated by the procurement entity in its Technical Specifications, are intended to be descriptive only and not restrictive. The Tenderer may substitute alternative standards, brand names, and/or catalogue numbers in its Tender, provided that it demonstrates to the Procurement entity's satisfaction that the substitutions ensure substantial equivalence to those designated in the Technical Specifications.

2.14 Tender Security

2.14.1 The Tenderer shall furnish, as part of its Tender, a Tender Security in the amount **equal to 1% of the Bid Sum.**

2.14.2 The Tender security is required to protect the **County Government of Marsabit** against the risk of Tenderer's conduct which would warrant the security's forfeiture, pursuant to paragraph 2.14.7

2.14.3 The Tender security shall be denominated in Kenya Shillings or in another freely convertible currency, and shall be in the form of a bank guarantee or a bank draft issued by a reputable bank located in Kenya or abroad, in the form provided in the Tender documents or another form acceptable to the **County Government of Marsabit** and valid for thirty (30) days beyond the validity of the Tender.

2.14.4 Any Tender not secured in accordance with paragraph 2.14.1 and 2.14.3 will be rejected by the **County Government of Marsabit** as non-responsive, pursuant to paragraph 2.22.

2.14.5 Unsuccessful Tenderer's Tender security will be discharged or returned promptly but not later than thirty (30) days after the expiration of the period of Tender validity prescribed by the **County Government of Marsabit**.

2.14.6 The successful Tenderer's Tender security will be discharged upon the tenderer signing the contract, pursuant to paragraph 2.30, and furnishing the performance security, pursuant to paragraph 2.31.

2.14.7 The Tender security may be forfeited:

(a) If a Tenderer withdraws its Tender during the period of Tender validity specified by the **County Government of Marsabit** on the Tender Form: or

(b) In the case of successful Tenderer, if the Tenderer fails:

(i) to sign the contract in accordance with paragraph 2.30

or

(ii) to furnish performance security in accordance with paragraph 2.31.

2.15 Validity of Tenders

2.15.1 Tenders shall remain valid for 120 days or as specified in the Tender documents after date of Tender opening prescribed by the County Government of Marsabit, pursuant to

paragraph 2.18. A Tender valid for a shorter period shall be rejected by the **County Government of Marsabit** as non-responsive.

2.15.2 In exceptional circumstances, the **County Government of Marsabit** may solicit the Tender's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing. The Tender security provided under paragraph 2.14 shall also be suitably extended. A Tenderer may refuse the request without forfeiting its Tender security. A Tenderer granting the request will not be required nor be permitted to modify its Tender.

2.16 Format and Signing of Tender

2.16.1 The tenderer shall prepare two copies of the Tender, clearly marking each "ORIGINAL TENDER" and "COPY OF TENDER," as appropriate. In the event of any discrepancy between them, the original shall govern.

2.16.2 The original and all copies of the Tender shall be typed or written in indelible ink and shall be signed by the Tenderer or a person or persons duly authorized to bind the Tenderer to the contract. The latter authorization shall be indicated by written power-of-attorney accompanying the tender. All pages of the tender, except for unamended printed literature shall be initialed by the person or person signing the tender.

2.16.3 The tender shall have no interlineations, erasures, or overwriting except as necessary to correct errors made by the Tenderer, in which case such corrections shall be initialed by the person or persons signing the tender.

SUBMISSION OF TENDERS

2.17 Sealing and Marking of Tenders

2.17.1 The Tenderer shall seal the original and each copy of the Tender in separate envelopes, duly marking the envelopes as "ORIGINAL" and "COPY". The envelopes shall then be sealed in an outer envelope.

2.17.2 The inner and outer envelopes shall:

(a) be addressed to the **County Government of Marsabit** at the following address:

the Invitation for Tenders (IFT), and the words: “DO NOT OPEN BEFORE,” **10:00am on Wednesday 31st October, 2018**

2.17.3 The inner envelopes shall also indicate the name and address of the Tenderer to enable the Tender to be returned unopened in case it is declared “late”.

2.17.4 If the outer envelope is not sealed and marked as required by paragraph 2.17.2, the **County Government of Marsabit** will assume no responsibility for the Tender’s misplacement or premature opening.

2.18 Deadline for Submission of Tenders

2.18.1 Tenders must be received by the **County Government of Marsabit** at the address specified under paragraph 2.17.2 not later than **10:00am on Wednesday 31st October, 2018**

2.18.2 The **County Government of Marsabit** may, at its discretion, extend this deadline for the submission of Tenders by amending the Tender documents in accordance with paragraph 2.6.3 in which case all rights and obligations of the **County Government of Marsabit** and candidates previously subject to the deadline will thereafter be subject to the deadline as extended.

2.19 Modification and Withdrawal of Tender

2.19.1 The Tenderer may modify or withdraw its Tender after the Tender’s submission, provided that written notice of the modification, including substitution or withdrawal of the Tenders, is received by the **County Government of Marsabit** prior to the deadline prescribed for submission of Tenders.

2.19.2 The Tenderer’s modification or withdrawal notice shall be prepared, sealed marked, and dispatched in accordance with the provisions of paragraph 2.17. A withdrawal notice may also be sent by cable, but followed by a signed confirmation copy, postmarked not later than the deadline for submission of Tenders.

2.19.3 No Tender may be modified after the deadline for submission of Tenders.

2.19.4 No Tender may be withdrawn in the interval between the deadline for submission of Tenders and the expiration of the period of Tender validity specified by the Tenderer on the tender form. Withdrawal of a Tender during this interval may result in the Tenderer’s forfeiture of its Tender security, pursuant to paragraph 2.14.7.

OPENING AND EVALUATION OF TENDERS

2.20 Opening of Tenders

2.20.1 The **County Government of Marsabit** will open all Tenders in the presence of Tenderers' representatives who choose to attend on **10:00 am on Wednesday 31st October, 2018** in the Procurement Board Room, ground floor; Governor's Office building. The tenderers' representatives who are present shall sign a register evidencing their attendance.

2.20.2 The Tenderers' names, tender modifications or withdrawals, tender prices, discounts, and the presence or absence of requisite tender security and such other details as the **County Government of Marsabit**, at its discretion, may consider appropriate, will be announced at the opening.

2.20.3 The **County Government of Marsabit** will prepare minutes of the tender opening.

2.21 Clarification of Tenders

2.21.1 To assist in the examination, evaluation and comparison of Tenders the **County Government of Marsabit** may, at its discretion, ask the Tenderer for a clarification of its tender. The request for clarification and the response shall be in writing, and no change in the prices or substance of the tender shall be sought, offered, or permitted.

2.21.2 Any effort by the Tenderer to influence the **County Government of Marsabit** in the tender evaluation, tender comparison or contract award decisions may result in the rejection of the Tenderer's tender.

2.22 Preliminary examination

2.22.1 The **County Government of Marsabit** will examine the Tenders to determine whether they are complete, whether any computational errors have been made, whether required sureties have been furnished, whether the documents have been properly signed, and whether the tenders are generally in order.

2.22.2 Arithmetical errors will be rectified on the following basis. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail, and the total price shall be corrected. If the candidate does not accept the correction of the errors, its Tender will be rejected, and its Tender security may be forfeited. If there is a discrepancy between words and figures, the amount in words will prevail.

2.22.3 The **County Government of Marsabit** may waive any minor informality or non-conformity or irregularity in a tender which does not constitute a material deviation, provided such waiver does not prejudice or affect the relative ranking of any Tenderer.

2.22.4 Prior to the detailed evaluation, pursuant to paragraph 2.23, the **County Government of Marsabit** will determine the substantial responsiveness of each tender to the tender documents. For purposes of these paragraphs, a substantially responsive tender is one, which conforms to all the terms and conditions of the tender documents without material deviations. The **County Government of Marsabit** determination of a Tender's responsiveness is to be based on the contents of the tender itself without recourse to extrinsic evidence.

2.22.5 If a tender is not substantially responsive, it will be rejected by the **County Government of Marsabit** and may not subsequently be made responsive by the Tenderer by correction of the nonconformity.

2.23 Evaluation and Comparison of Tenders

2.23.1 The **County Government of Marsabit** will evaluate and compare the Tenders, which have

been determined to be substantially responsive, pursuant to paragraph 2.22.

2.23.2 The **County Government of Marsabit** evaluation of a tender will exclude and not take into account.

a) in the case of goods manufactured in Kenya or goods of foreign origin already located in Kenya, sales and other similar taxes, which will be payable on the goods if a contract is awarded to the Tenderer; and

b) any allowance of price adjustment during the period of execution of the contract, if provided in the tender.

2.23.3 The comparison shall be of the ex-factory/ex-warehouse/off-the-shelf price of the goods offered from within Kenya, such price to include all costs, as well as duties and taxes paid or payable on components and raw material incorporated or to be incorporated in the goods.

2.23.4 The **County Government of Marsabit** evaluation of a tender will take into account, in addition to the tender price and the price of incidental services, the following factors, in the manner and to the extent indicated in paragraph 2.23.5 and in the technical specifications:

- a) delivery schedule offered in the tender
- b) deviations in payment schedule from that specified in the special conditions of contract;
- c) the cost of components, mandatory spare parts, and service;
- d) the availability in Kenya of spare parts and after-sales services for the equipment offered in the tender;

2.23.5 Pursuant to paragraph 2.23.4 the following evaluation methods will be applied:

(a) Delivery Schedule.

- (i) The **County Government of Marsabit** requires that the goods under the Invitation for Tenders shall be delivered at the time specified in the Schedule of Requirements. Tenders offering deliveries longer than the **County Government of Marsabit** required delivery time will be treated as non-responsive and rejected.

(b) Deviation in payment schedule.

Tenderers shall state their tender price for the payment on a schedule outlined in the special conditions of contract. Tenderers will be evaluated on the basis of this base price. Tenderers are, however, permitted to state an alternative payment schedule and indicate the reduction in tender price they wish to offer for such alternative payment schedule. The **County Government of Marsabit** may consider the alternative payment schedule offered by the selected Tenderer.

2.24 Contacting the County Government of Marsabit

2.24.1 Subject to paragraph 2.21.2, no Tenderer shall contact the **County Government of Marsabit** on any matter relating to its Tender, from the time of the Tender opening to the time the contract is awarded.

2.24.2 Any effort by a Tenderer to influence the **County Government of Marsabit** in its decisions on tender evaluation, tender comparison, or contract award may result in the rejection of the Tenderer's tender.

AWARD OF CONTRACT

2.25 Post-Qualification

2.25.1 In the absence of pre-qualification, the **County Government of Marsabit** will determine to its satisfaction whether the Tenderer that is selected as having submitted the lowest evaluated responsive tender is qualified to perform the contract satisfactorily.

2.25.2 The determination will take into account the Tenderers financial, technical, and production capabilities. It will be based upon an examination of the documentary evidence of the Tenderers qualifications submitted by the Tenderer, pursuant to paragraph 2.12.3, as well as such other information as the **County Government of Marsabit** deems necessary and appropriate.

2.25.3 An affirmative determination will be a prerequisite for award of the contract to the Tenderer. A negative determination will result in rejection of the Tenderer's tender, in which event the **County Government of Marsabit** will proceed to the next lowest evaluation tender to make a similar determination of that Tenderer's capabilities to perform satisfactorily.

2.26 Award Criteria

2.26.1 Subject to paragraph 2.10, 2.23 and 2.28 the **County Government of Marsabit** will award the contract to the successful Tenderer (s) whose tender has been determined to be substantially responsive and has been determine to be the lowest evaluated tender, provided further that the Tenderer is determined to be qualified to perform the contract satisfactorily.

2.27 County Government of Marsabit Right to Vary Quantities

2.27.1 The **County Government of Marsabit** reserves the right at the time of contract award to increase or decrease the quantity of goods originally specified in the schedule of requirements without any change in unit price or other terms and conditions.

2.28 County Government of Marsabit Right to accept or Reject Any or All Tenders

2.28.1 The **County Government of Marsabit** reserves the right to accept or reject any tender, and to annul the Tendering process and reject all Tenders at any time prior to contract award, without thereby incurring any liability to the affected Tenderer or Tenderers or any obligation to inform the affected Tenderer or Tenderers of the grounds for the County Government of Marsabit action.

2.29 Notification of Award

2.29.1 Prior to the expiration of the period of tender validity, the **County Government of Marsabit** will notify the successful Tenderer in writing that its tender has been accepted and simultaneously notify the unsuccessful tenderer's of the fact.

2.29.2 The notification of award will constitute the formation of the contract.

2.29.3 Upon the successful Tenderers furnishing of the performance security pursuant to paragraph 2.31, the **County Government of Marsabit** will promptly notify each unsuccessful Tenderer and will discharge its tender security, pursuant to paragraph 2.14.

2.30 Signing of Contract

2.30.1 At the same time as the **County Government of Marsabit** notifies the successful Tenderer that its tender has been accepted, the **County Government of Marsabit** will send the Tenderer the Contract Form provided in the tender documents, incorporating all agreements between the parties.

2.30.2 Within thirty (30) days of receipt of the Contract Form, the successful Tenderer shall sign and date the contract and return it to the **County Government of Marsabit**.

2.31 Performance Security

2.31.1 Within fourteen (14) days of the receipt of notification of award from the **County Government of Marsabit**, the successful Tenderer shall furnish the performance security in accordance with the Conditions of Contract, in the Performance security Form provided in the tender documents or in another form acceptable to the **County Government of Marsabit**.

2.31.2 Failure of the successful Tenderer to comply with the requirement of paragraph 2.30 or paragraph 2.31 shall constitute sufficient grounds for the annulment of the award and forfeiture of the tender security, in which event the **County Government of Marsabit** may make the award to the next lowest evaluated or call new Tenders.

2.32 Corrupt Fraudulent Practices

2.32.1 The **County Government of Marsabit** requires that Tenderers observe the highest standard of ethics during the procurement process and execution of contracts. In pursuance of this policy, the **County Government of Marsabit**: -

- (a) defines, for the purpose of this provision, the terms set forth below as follows: -
 - (i) “Corrupt practice” means the offering, giving, receiving or soliciting of any thing of value to influence the action of the public official in the procurement process or in contract execution; and
 - (ii) “ Fraudulent practice” means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of the **County Government of Marsabit**, and includes collusive practice among Tenderer (prior to or after tender submission) designed to establish tender prices at artificial non-competitive levels and to deprive the **County Government of Marsabit** of the benefits of free and open competition;
- (b) will reject a proposal for award if it determines that the Tenderer recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question;
- (c) will declare a firm ineligible, either indefinitely or for a stated period of time, to be awarded any contract if it at any time determines that the firm has engaged in corrupt or fraudulent practices in competing for, or executing a contract.

2.32.2 Furthermore, Tenderers shall be aware of the provision stated in the General conditions of Contract.

3 GENERAL CONDITONS OF CONTRACT

3.1 Definitions

In this Contract, the following terms shall be interpreted as indicated:

- (a)“The Contract” means the agreement entered into between the **County Government of Marsabit** and the Tenderer, as recorded in the Contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- (b)“The Contract Price” means the price payable to the Tenderer under the contract for the full and proper performance of its contractual obligations.
- (c)“The Goods” means all of the equipment, machinery, and/or other materials, which the Tenderer is required to supply to the **County Government of Marsabit** under this contract.
- (d)“The **County Government of Marsabit**” means the organization purchasing the Goods under this Contract.
- (e)“The Tenderer” means the individual or firm supplying the Goods under this Contract.

3.2 Application

These General Conditions shall apply in all Contracts made by the **County Government of Marsabit** for the procurement of goods.

3.3 Country of Origin

For purposes of this clause, “Origin” means the place where the Goods were mined, grown, or produced.

The origin of Goods and services is distinct from the nationality of the Tenderer.

3.4 Standards

The Goods supplied under this Contract shall conform to the standards mentioned in the Technical Specifications.

3.5 Use of Contract Documents and Information

- 3.5.1 The Candidate shall not, without the **County Government of Marsabit** prior written consent, disclose the Contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the **County Government of Marsabit** in connection therewith, to any person other than a person employed by the Tenderer in the performance of the Contract.
- 3.5.2 The Tenderer shall not, without the **County Government of Marsabit** prior written consent, make use of any document or information enumerated in paragraph 3.5.1 above.
- 3.5.3 Any document, other than the Contract itself enumerated in paragraph 3.5.1 above, shall remain the property of the **County Government of Marsabit** and shall be returned (all copies) to the **County Government of Marsabit** on completion of the Tenderer's performance under the Contract if so required by the **County Government of Marsabit**.

3.6 Patent Rights

The Tenderer shall indemnify the **County Government of Marsabit** against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the Goods or any part thereof in the **County Government of Marsabit** country.

3.7 Performance Security

- 3.7.1 Within fourteen (14) days of receipt of the notification of Contract award, the successful Tenderer shall furnish to the **County Government of Marsabit** the performance security in the amount specified in Special Conditions of Contract.
- 3.7.2 The proceeds of the performance security shall be payable to the **County Government of Marsabit** as compensation for any loss resulting from the Tenderer's failure to complete its obligations under the contract.
- 3.7.3 The performance security shall be denominated in the currency of the Contract, or in a freely convertible currency acceptable to the **County Government of Marsabit** and shall be in the form of a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in Kenya or abroad, acceptable to the **County Government of Marsabit**, in the form provided in the Tender documents.

3.7.4 The performance security will be discharged by the **County Government of Marsabit** and returned to the Candidate not later than thirty (30) days following the date of completion of the Tenderer's performance obligations under the Contract, including any warranty obligations, under the Contract. **County Government of Marsabit**

3.8 Inspection and Tests

3.8.1 The **County Government of Marsabit** or its representative shall have the right to inspect and/or test the goods to confirm their conformity to the Contract specifications. The **County Government of Marsabit** shall notify the Tenderer in writing, in a timely manner, of the identity of any representatives retained for these purposes.

3.8.2 The inspections and tests may be conducted on the premises of the Tenderer or its sub-supplier (s), at point of delivery, and/or at the goods, final destination. If conducted on the premises of the Tenderer or its sub-supplier(s), all reasonable facilities and assistance, including access to drawings and production data, shall be furnished to the inspectors at no charge to the **County Government of Marsabit**.

3.8.3 Should any inspected or tested Goods fail to conform to the specifications, the **County Government of Marsabit** may reject the goods, and the Tenderer shall either replace the rejected Goods or make alterations necessary to meet specification requirements free of cost to the **County Government of Marsabit**.

The **County Government of Marsabit** right to inspect, test and, where necessary, reject the goods after the Goods' arrival shall in no way be limited or waived by reason of the goods having previously been inspected, tested, and passed by the **County Government of Marsabit** or its representative prior to the goods' delivery.

3.8.4 Nothing in paragraph 3.8 shall in any way release the Tenderer from any warranty or other obligations under this contract.

3.9 Packing

The Tenderer shall provide such packing of the Goods as required to prevent their damage or deterioration during transit to their final destination as indicated in the contract.

The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the Contract.

3.10 Delivery and Documents

Delivery of the goods shall be made by the Tenderer in accordance with the terms specified by **County Government of Marsabit** in its schedule of Requirements and the special Conditions of Contract.

3.11 Insurance

The Goods supplied under the Contract shall be fully insured against loss or damage incidental to manufacture or acquisition, transportation, storage, and delivery in the manner specified in the special conditions of contract.

3.12 Payment

3.12.1 The method and conditions of payment to be made to the Tenderer under this Contract shall be specified in special Conditions of Contract.

3.12.2 Payments shall be made promptly by the **County Government of Marsabit** as specified in the contract.

3.13 Prices

3.13.1 Prices charged by the Tenderer for goods delivered and services performed under the Contract shall not, with the exception of any price adjustments authorized in special Conditions of contract, vary from the prices by the Tenderer in its Tender.

3.14 Assignment

3.13.1 The Tenderer shall not assign, in whole or in part, its obligations to perform under this Contract, except with the **County Government of Marsabit** prior written consent.

3.14 Subcontracts

3.15.1 The Tenderer shall notify the **County Government of Marsabit** in writing of all subcontracts awarded under this Contract if not already specified in the Tender. Such notification, in the original Tender or later, shall not relieve the Tenderer from any liability or obligation under the Contract.

3.16 Termination for Default

3.16.1 The **County Government of Marsabit** may, without prejudice to any other remedy for breach of Contract, by written notice of default sent to the Tenderer, terminate this Contract in whole or in part.

(a)if the Tenderer fails to deliver any or all of the goods within the period(s) specified in the Contract, or within any extension thereof granted by the **County Government of Marsabit**.

(b)If the Tenderer fails to perform any other obligation(s) under the Contract.

(c) If the Tenderer, in the judgment of the **County Government of Marsabit** has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.

3.16.2 In the event the **County Government of Marsabit** terminates the Contract in whole or in part, it may procure, upon such terms and in such manner as it deems appropriate, goods similar to those undelivered, and the Tenderer shall be liable to the **County Government of Marsabit** for any excess costs for such similar Goods.

3.17 Liquidated Damages

3.17.1 If the Tenderer fails to deliver any or all of the goods within the period (s) specified in the contract, the **County Government of Marsabit** shall, without prejudice to its other remedies under the contract, deduct from the contract prices liquidated damages sum equivalent to 0.5% of the price of the undelivered goods up to a maximum deduction of 10% of the undelivered goods. After this the Tenderer may consider termination of the contract.

3.18 Resolution of Disputes

3.18.1 The **County Government of Marsabit** and the Tenderer shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute arising between them under or in connection with the contract.

3.18.2 If after thirty (30) days from the commencement of such informal negotiations both parties have been unable to resolve amicably a contract dispute the provision of the arbitration Act of the Laws of Kenya shall apply.

3.19 Language and Law

3.19.1 The Language of the contract and the law governing the contract shall be English language and the laws of Kenya respectively unless otherwise stated.

3.20 Force Majeure

3.20.1 The Tenderer shall not be liable for forfeiture of its performance security, or termination for default if and to the extent that its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.

SPECIAL CONDITIONS OF CONTRACT

- 4.1 Special Conditions of Contract shall supplement the General Conditions of Contract. Whenever there is a conflict, the provisions herein shall prevail over those in the General Conditions of Contract.
- 4.2 The **County Government of Marsabit** shall issue Local Purchase Orders for supply and delivery of various units as and when required during the contract validity period. Payment shall be made after the goods have been supplied and accepted that they are in good order and comply to specifications.
- 4.3 Where in doubt, the County shall randomly sample the goods and subject them to compliance testing. No payment shall be made until the Test certificates have been received. If the goods are rejected the supplier shall be required to take away the affected goods and replace with others that comply at their cost.
- 4.4 To be noted under special conditions of contract. The **County Government of Marsabit** shall have a right and would not be held responsible for not issuing the Local Purchase Order for the total quantities in the Contract.
- 4.5 The **County Government of Marsabit** requires that the Tender document **MUST** be submitted in the same form as provided without any mutilation.

TECHNICAL EVALUATION CRITERIA

- a) Responsiveness at preliminary stage **shall qualify** candidates to technical Evaluation stage.
